1	17/1	<p>Does a driver commit an offence if he/she lets a person who does not hold the relevant driving licence drive the motor vehicle?</p> <p>yes no</p>	
1	17/2	<p>Does a driver commit an offence if he/she exceeds the permissible speed limit although this does not create any immediate danger to the traffic?</p> <p>yes no</p>
